## RULES

Full rules provided at request. Following is an abridged version.

### Format of Golf Tournament

Rules of the Royal & Ancient (2008 Ed) shall apply.

The tournament shall be on a Team as well as individual basis.

### Team Format

Each team shall consist of 2 players who must be from the same organization. Participating teams must be from law firms practicing in Singapore, members of the judiciary, members of the Singapore legal fraternity.

The organizers shall have the discretion to invite any other suitable organizations related to the practice of law in Singapore to participate.

### Handicap

Each player shall play of his lowest current handicap.

### Scoring

- Individual

Each player's score shall be recorded by a marker on an individual card. Marker is to write the **gross score** on each hole; however the responsibility of accurate scoring lies with the player.

*Players must hole out. No Gimmes. However, if a player is no longer in contention for the individual prizes of best gross or best nett score, he may take a gimme 'within putter length' and add one stroke to his score.*

- Team

For the reckoning for team score, the better nett score on each hole will be taken into account and the team with the lowest "best ball" score over 18 holes shall be declared the winner.

### Team Challenge Trophy

The Challenge Trophy will be presented to the winner who must keep safe custody of the Challenge Trophy until requested to return the same to the Law Society.

### Knowles Cup, CC Tan Cup and Wee Chong Jin Cup

- 1) The Knowles Cup will be presented to the Lowest Nett Score (Strokeplay)
- 2) The Wee Chong Jin Cup will be presented to the Lowest Gross Score (Strokeplay)
- 3) The CC Tan Cup will be presented to the player with the Highest Stableford points.

### Disputes

All disputes shall be referred to the Organizing Committee for a decision and whose ruling shall be final and binding.
